1. **All required information must be provided on this entry form. One form per entrant.**
2. Fill out the TICKET ORDER FORM.
3. Make check payable to TTC and mail to: 300 Woodland Rd, Sequatchie, TN 37374 info 423-942-8688
4. **AMA Membership Cards must be presented at the event or the contestant must join AMA at event**
5. Parent/Legal Guardian/Authorized Adult for the minor must remain present at all times during participation by the minor in any AMA sanctioned event. An authorized adult is an adult that has been given the authority by the parent or legal guardian to be responsible for the minor. This authority must be in writing, notarized and given to the organizer at registration. The parent, legal guardian or authorized adult must sign a minor release form at the event.
6. Youth competitors must bring proof of age to the event.
7. Pre-entry for all 3 rounds is \$90.00 payable by check. Tickets are required for admission to the site for all accompanying adults and children not pre-entered in the Youth Championship or US Women's Open. Late Entry is \$40/day.
8. Deadline for pre-entry is 6/10/06 Requests for refund postmarked prior to 6/10 will be made in full. None thereafter.
9. Riders must wear a suitable garment with name on back. All rider bikes must display a proper number plate, designating their name and class. All minder bikes must display "minder" and the rider's name and class for whom they are minding.

- Youth Nat'l Competitor Pre entry is for youth competitors age 6-14 as of January 01, 2006 for entrance to all 3 Youth Rounds (Sat., Sun., & Mon.) and for all activities and events.
- Women's Open Competitor Pre-entry is for all female riders, of any age or skill, for entrance to all 3 Rounds (Sat., Sun., & Mon.) and for all activities and events. If a female YOUTH rider also wants to participate in awards/points for the US Women's Open - **there is NO add'l charge**
- Open Class is open to riders of all ages, but must ride the line designated as "O"

Family Youth Camp Admissions are for all persons on TTC property during the week of June 26, 2006 - July 3, 2006. Includes all activities and meals on the Schedule, except for field trips taken away from the TTC. Also includes National spectator admission for all three days of competition.

Youth National Weekend ONLY admissions are for Saturday thru Monday and includes the bar-b-que on Saturday evening.

Primitive camping in the pits area is \$15 (including tax) and should be **paid immediately upon arrival**. You will be given a camping pass, which should be posted in a visible site. One family per camping site is allowed.

All RV sites with hookups and all cabins have been reserved and held by deposit. If you have reserved one of these sites, balance of payment in full should accompany your registration form. Please call Catherine Bedley for balance due.
